
ACTION AGENDA:

4. Vote to approve the release of the following CD's to Aginaldo Zamora dba A Bail Bonds. CD #'s 03900316949, \$7500.00, 03900316950, \$5000.00, 03900316959, \$7500.00, 03900316960, \$5000.00, 03900316834, \$5000.00 and 03900316837, \$7500.00, the total amount of release would be \$37,500.00. As of the date of this request, the amount of outstanding for A Bail Bonds was \$3,068,160.20 with a writing power of \$3,536,100.00. If the release is approved their writing power will decrease to \$3,161,100.00 leaving a balance of \$92,939.80 to write with. There are ample funds with the CD's that remain assigned to the County to cover the current outstanding in the event the board approves these releases.
