This cause was called for trial in Comal County, Texas. The State appeared by her District Attorney.

Counsel / Waiver of Counsel (select one)

- Defendant appeared in person with Counsel.
- Defendant knowingly, intelligently, and voluntarily waived the right to representation by counsel in writing in open court, and is not indigent.

The State filed a motion to revoke Defendant's community supervision. After hearing the State's motion, Defendant's plea, the evidence submitted, and reviewing the record, the Court **GRANTS** the State's motion. The Court's record indicates that Defendant was previously convicted of a misdemeanor offense and punishment was assessed as indicated above. The record indicates the Court ordered imposition of Defendant's sentence of confinement suspended and placed Defendant on community supervision for _____ Months.

The Court **FINDS** Defendant has violated the conditions of community supervision as set out in the State's Motion to Revoke Community Supervision as attached hereto:

Accordingly, the Court **ORDERS** the previous orders in this cause suspending imposition of sentence of confinement and placing Defendant on community supervision **REVOKED. (select one of the following)**

The Court **ORDERS** Defendant immediately committed to the custody of the Sheriff of Comal County, Texas on the date the sentence is to commence. Defendant shall be confined in the Comal County Jail for the period indicated above. The Court **ORDERS** that upon release from confinement, Defendant shall proceed immediately to the the Comal County Collections Office, 100 Main Plaza, Suite 301, Comal County Courthouse, New Braunfels, Texas 78130. Once there, the Court **ORDERS** Defendant to pay, or make arrangements to pay, any remaining unpaid fines, court costs, and restitution as ordered by the Court above.

- Fine Only Payment.**

The punishment assessed against Defendant is for a **FINE ONLY**. The Court **ORDERS** Defendant to proceed immediately to the the Comal County Collections Office, 100 Main Plaza, Suite 301, Comal County Courthouse, New Braunfels, Texas 78130. Once there, the Court **ORDERS** Defendant to pay or make arrangements to pay all fines and court costs as ordered by the Court in this cause.


- The Court **ORDERS** Defendant's sentence **EXECUTED**.
