**Supporting McMullen County’s request to transfer its affiliation with the Workforce Solutions of the Coastal Bend to the Workforce Solutions Alamo to align with its membership with the Alamo Area Council of Governments (AACOG)**

**WHEREAS**, McMullen County is a member in good standing of the Coastal Bend Workforce Development Area, operating under the business name Workforce Solutions of the Coastal Bend (WSCB) whose main offices are located in Corpus Christi, TX; and

**WHEREAS**, McMullen County is one of 12 Counties, Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, McMullen, Nueces, Refugio and San Patricio that comprise WSCB; and

**WHEREAS**, McMullen County is a member in good standing of the Alamo Area Council of Governments (AACOG), and one of 13 Counties, Atascosa, Bandera, Bexar, Comal, Frio, Guadalupe, Gillespie, Karnes, Kendall, Kerr, McMullen, Medina and Wilson making up AACOG, whose main offices are located in San Antonio, TX ; and

**WHEREAS**, McMullen County is the most Westerly County located in the WSCB region; and

**WHEREAS**, McMullen County is located adjacent to the Alamo Workforce Development Board Area; specifically Atascosa and Frio Counties, which share very similar labor market challenges, demands and opportunities due to oil and gas industry-related activities in the Eagle Ford Shale; and

**WHEREAS**, McMullen County wishes to transfer its Workforce Development affiliation to the Alamo Area Workforce Region operating under the business name Workforce Solutions Alamo (WSA), in order to align its membership with the AACOG, because of a closer proximity to available workforce services, a much stronger similarity in relationships, experiences and a shared nature of challenges, demands and opportunities.

**NOW, THEREFORE BE IT RESOLVED THAT**, the Comal County Commissioners Court, does hereby approve this resolution supporting McMullen County transferring from the Coastal Bend Workforce Development Area to the Alamo Area Workforce Development Area.
